RULES & REGULATIONS

1. PRELIMINARY

The University School of Law, Rayat Bahra University (Mohali) announces its **8th RBU Moot Court Competition, 2025**. The competition has strict rules and regulations for the purpose and duration of this competition, the compliance of which is mandatory. The rules are as mentioned below

2. AIM & PURPOSE

The 8th RBU Moot Court Competition has the aim to -

- i. Create awareness on various subjects of Law and train participants for effective practice.
- ii. Facilitate the knowledge of the jurisprudential analysis of existing laws and consequential emergence of new laws besides developing cutting edge skills in research, legal writing and advocacy.

3. DEFINITIONS

- i. “Bench” refers to the members duly invited to adjudicate the Oral Rounds, Individually or Collectively.
- ii. “Clarifications” refers to the requests for information with respect to the Moot Proposition
- iii. “Compendium” refers to the collection of judgements and resources used to support the oral and written submissions of the party.
- iv. “Organizing Committee” means the Committee for conducting the competition.
- v. “Penalty” implies the consequences, in case a team or any of its participants do not adhere to the rules.

- vi. “Plagiarism” refers to the direct or substantial duplication of work represented as one's own, without acknowledgement.
- vii. “Proof of Enrolment” shall include College Identity Card or admit card or a similar document.
- viii. “Rebuttals” refers to the challenges put forward by the appellant in response to the respondent's submissions.
- ix. “Soft copy” of a document includes the document in PDF (.pdf) format.

4. GENERAL RULES

- 4.1. **DATE AND VENUE:** The 8thRBU Moot Court Competition shall be held Offline on 8th& 9th March, 2025.
- 4.2. **ELIGIBILITY:** The competition is open for all and any student who is pursuing LLB (three year) / BA.LL.B/ B.COM.LL.B/ B.BA.LL.B (five year) course during the current academic year.
- 4.3. **LANGUAGE:** All oral and written submissions shall be in English language.
- 4.4. **TEAM COMPOSITION:**
 - i. Each team should consist of 3 members. This number cannot be modified under any circumstances.
 - ii. There shall be 2 speakers and 1 researcher designated for each team. The researcher shall be allowed to argue with prior permission of the court and Moot Conveners in case of illness of the designated speakers.
 - iii. Each team will be provided a team code prior to the submission of memorials via e- mail. This team code shall remain the same for the memorials and the oral rounds.
 - iv. Only one team from every institution is allowed.
- 4.5. **CLARIFICATIONS:** Clarifications on the moot proposition may be sought before 18th February 2025 with an email to

mcs.usl@rayatbakrauniversity.edu.in. The release of clarifications shall be on 19th February 2025.

4.6 THE ORAL ROUNDS SHALL COMPRISE OF:

- (i) Memorial Round (Memorial Based Selection)
- (ii) Qualifier Rounds(Two)
- (iii) Quarter – Final Round
- (iv) Semi – Final Round
- (v) Final Round

4.7 ACCOMMODATION:

The participants would be provided accommodation on sharing basis at the premises of the Institute/any other suitable premises during the competition. Please note that separate accommodation will be provided for girls and boys.

Accommodation will be provided for 8th- 9th March 2025 Evening.

NOTE: We will not allow any additional Member for accommodation during the moot court competition

4.8 DRESS CODE: The dress code for the competition is an advocate's uniform as per Advocates Act, 1961 without band and gown. Violation of the dress code will bar a contestant from appearing in the pleading rounds.

4.8 COURT MANNERISMS: All participants are required to conduct themselves in a responsible and professional manner throughout the competition. All participants are required to act in a dignified manner and respect the Court. Members of a participating team must not communicate with the Judges or opposite counsels in private, to the detriment of the competition.

5. REGISTRATIONS

- 5.1 **DATE OF REGISTRATION:** All the participating institutions have to register themselves on provided registration link https://docs.google.com/forms/d/e/1FAIpQLSe_WEMIGPXY1e3mtJIN1_Jyx3RWMcbalpM7ayTckNaNvI4SDQ/viewform?usp=header and confirm team participation by sending an email to mcs.usl@rayatbahrauniversity.edu.in on or before 15th February 2025.
- 5.2 After Memorial Round 16 teams shall qualify for the Qualifier Round.
- 5.3 **FEE DETAILS:** Fee for oral rounds - Rs 4,000/- Per Team (including accommodation and food)
Note:- There will be no registration cost. Only qualified teams must pay an oral round fee; the Team Leads will be sent a message with the bank account details via mail.
- 5.4 **ALLOTMENT OF TEAM CODE:** Every team which has successfully completed the Registration requisites under the Rules shall be allotted a unique code with an approval for participation of their team for competition via mail. Once allotted, every team must use the team code for any communication with the Organizers during the Competition.
- 5.5 **FORMAL REGISTRATION:** The formal registration of the teams shall be done on 8th March, 2025 at the venue i.e. University school of Law, Rayat Bahra University.
- 5.6 Any delay in the registration procedure or compliance with the registration formalities or partially complying after the expiry of the scheduled dates of registration, **WILL BE TERMED AS NO REGISTRATION**, therefore, no claim subsists for the team thereafter.
- 5.7 If a team notifies the organizers of its withdrawal or absence from

participation in the competition, such team **SHALL NOT BE ENTITLED TO THE REFUND** of the registration fees or any amount which has been paid in the registration process.

6. FORMAT OF THE COMPETITION

6.1 ORIENTATION: There will be an Orientation Program for all the participants on 8th March 2025. It will be followed by a draw of lots and exchange of memorials for the Qualifier Round.

6.2 RESEARCHER'S TEST:

The Researcher Test will take place on **8th March, 2025** to determine the best researcher.

1. In a team consisting of three members, the member designated as Researcher shall take part in the test.
2. Participants are requested to write only the Team Code on the question paper.
3. The Researcher's Test shall be objective with the questions based on the applicable law, precedents and facts pertaining to the Moot Problem.
4. The duration of the Researcher's Test shall be **30 minutes**.
5. The use of mobile phones, laptops, or any other electronic gadgets/written material is strictly prohibited during the Researcher Test.
6. Score of the Researcher's Test shall be computed as the total score in Researcher's test.
7. The Winner of the Test shall be determined on the basis of highest score attained.

NOTE: The Speakers of any team will not be allowed to sit in the Researcher Test in any case

6.3 DRAW OF LOTS: Before every round, the draw of lots shall be done to determine the side on which the team shall be arguing i.e. Appellant or

Respondent. The Draw of Lots will also decide which team you will be competing against (there will be no pre-decided fixtures). In case, it becomes necessary due to withdrawal of any teams at the last moment or if the competing teams had no opportunity to argue the other side of the proposition, the organizers reserve the right to make any necessary alterations in respect of the side to be taken by the competing teams.

6.4 QUALIFIER ROUND:

- i. Qualifier round will be held offline on **8th March 2025**.
- ii. To ensure a well-rounded experience, Qualifier Round will consist of two parts, granting the chance to the participants for expressly arguing from both the Appellant and the Respondent sides of the Proposition.
- iii. The match ups for the Qualifier Round will be set by a random draw to ensure fairness and unpredictability.
- iv. No two teams shall face each other more than once in the Qualifier Rounds. However, such team may face each other in the Quarter Finals/ Semi Finals/ Final Rounds, subject to their qualification.
- v. Each team shall get a total of **30 minutes** to present their case. This time will exclude rebuttal (2 minutes) and sur-rebuttal (1 minute).
- vi. The division of time between the speakers is the discretion of the team members, subject to a maximum of **18 minutes** and minimum **12 minutes** per speaker. Each team shall indicate to the court master as to how it decides to allocate its **30 minutes**.
- vii. Speaker 1 and Speaker 2 to remain the same throughout the competition
- viii. Top eight teams from the Qualifier will advance to the Quarter final rounds.
- ix. Qualifier will be decided on the basis of
 - Total Score of the team in Qualifier Round I and Qualifier Round II
 - Total score of Qualifier Round I+ Qualifier Round II+ Memorial Round (In case of Tie in oral rounds)
- x. Teams will receive their opponents' memorials when Draw of lots for their individual sets are Concluded.

- xi. Return of the other side's memorial immediately after the preliminary round to the Court Masters is compulsory.

6.5 QUARTER FINAL ROUND:

- i. Quarter Final Round shall take place on **8th March, 2025**.
- ii. The top EIGHT(8) teams advancing to the Quarter-Finals Rounds, will each have the chance to argue **ONCE**, for the side they are randomly assigned by the draw of lots.
- iii. The teams will be provided with their opponent's memorial after the draw of lots for the Quarter Final Round.
- iv. Each team shall get a total of **30 minutes** to present their case. This time will Exclude rebuttal (3 minutes) and sur-rebuttal(2 minutes).
- v. The division of time between the speakers is the discretion of the team members, subject to a maximum of **18 minutes** and **12 minutes** minimum per speaker. Each team shall indicate to the court master as to how it decides to allocate its 30 minutes.
- vi. Quarter Final Round shall be knockout round.
- vii. The Winners of the Quarter-final shall advance to the Semi-finals.

6.6 SEMI FINAL ROUND

- i. The Semi Final Round shall be held on **9th March, 2025**.
- ii. The side to be represented by the team shall be determined by way of draw of lots.
- iii. For Semi -Final Round, each team shall get a total of **45 minutes** to present their case. This time will Exclude rebuttal (5 minutes) and sur-rebuttal (3 minutes).
- iv. The division of time between the speakers is the discretion of the team members, subject to a maximum of **25 minutes** and **20 minutes** minimum per speaker.
- v. Each team shall indicate to the court master as to how it decides to allocate its **45 minutes**.
- vi. Semi Final Round shall be knockout round.

6.7 FINAL ROUND

- i. The Final Round shall be held on **9th March, 2025**.
- ii. The side to be represented by the team shall be determined by way of draw of lots.
- iii. For Final Round, each team shall get a total of **45 minutes** to present their case. This time will Exclude rebuttal (5 minutes) and sur-rebuttal (3 minutes).
- iv. The division of time between the speakers is the discretion of the team members, subject to a maximum of **25 minutes** and **20 minutes** minimum per speaker.
- v. Each team shall indicate to the court master as to how it decides to allocate its 45 minutes.

6.8 MEMORIALS: The following requirements for memorials must be strictly followed. Non-conformities will be penalized:

- i. Each team must prepare memorials for both parties to the dispute (Applicant and Respondent).
- ii. The soft copy of the Memorials for the Applicant / and the Respondent should be emailed to mcs.usl@rayatbhrauniversity.edu.in on or before **24th February latest by 12:00 PM**.
- iii. All participating teams shall submit 5 sets of written memorials on **05th March, 2025 via postal service to the below mentioned address:**
 - iv. Late submission will be penalized by five points each per memorial per 4 hours.
 - v. Once the soft copy of the memorial has been submitted, no revisions, supplements, or additions will be allowed.
 - vi. The memorials must contain:
 - a) The Table of Contents
 - b) The Index of Authorities
 - c) The Statement of Jurisdiction

- d) The Statement of Facts (argumentative statement of facts would attract penalties)
- e) The Statement of Issues
- f) The Summary of Arguments (not more than 1 page)
- g) The Arguments Advanced (**not more than 30 pages**)
- h) The Prayer
- i) Appendix (Optional)
- j) Exhibits (Optional)
- vi. The font size should be 12 (one & half space) and for footnotes it should be 10 (single space). Footnoting must conform to the bluebook 20th edition for Citation.
- vii. The memorial must have a margin measuring one inch on all sides of each page.
- viii. Covers must be placed on briefs as follows: Applicant : Light Blue Color ; Respondent : Light Red Color.
- ix. The cover page of the memorial must state the following :
 - a) Team code (on the top right corner)
 - b) The cause title
 - c) Identify brief as Applicants & Respondents as is applicable
- x. The teams may share a separate paper book (compendium) of **not more than 50 pages**, which will carry all the annexure and case laws that have been referred to in the memorial. The paper book will have a white cover. The teams may submit it submitted during registration or before commencement of the competition or as advised by the organizers.

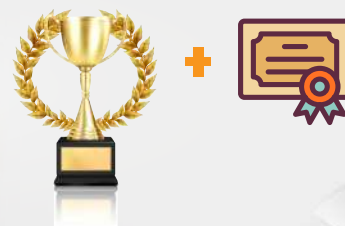
